Definition of each type of new item

- **Clearance**: Product initially stocked and put back on sale at a lower price than the original price, belonging to the following types: unsold, old collections, end of series or factory outlets.
- **Stock clearance**: Product sold for one of the following reasons: permanent cessation of activity, seasonal suspension of activity, substantial change in operating conditions.
- **Product with defect**: Product with a slight manufacturing defect that does not have the quality and/or performance expected of a new product of the same type.
- **Exhibition model**: Product often unpacked and sometimes used to display to customers for observation, trial or performance testing.
- **Creation / Craft**: Product manufactured or transformed in small quantities, either entirely by hand or using tools or mechanical means with the direct manual contribution of the craftsman.
- **Customer return** : Product that has recently been sold and returned to the seller in new condition but can no longer be sold at its original price because it has been unpacked or has damaged packaging.
- **Off-label product** : Product from which the brand has been removed before being put up for sale at a lower price than the original price.

Parent and children products

If the status of the parent product is New - Clearance, then all child products must also be New - Clearance.

Refurbished parent and children's products¶

If the status of the parent product is Refurbished – Good condition, the child products may have different refurbished statuses. For example, the status of a child product could be :

Parent product: Refurbished - Very good condition Children's product 1: Refurbished - Good condition Children's product 2: Refurbished - Satisfactory condition

Grouping refurbished products in a single ad¶

We recommend grouping refurbished products into a single listing. For the buyer, it streamlines their user journey:

- **Search**: Instead of reviewing X ads from the same seller for an identical product during a search, they can view a single ad.
- **Customization**: Buyers will encounter a single ad with all available options and choices, providing a better customization selection to meet their needs.

For the professional, it simplifies catalogue management:

• Managing a single product with multiple characteristics instead of handling multiple items.
